This has reference to your letter dated 5th January, 2009 for affiliation of a new college of Bachelor of Education (B.Ed.), proposed to be started at Kharegaon, Kalwa, Thane-400 605 from the academic year 2008-09.

In this connection, I am directed to inform you that considering the permission granted by the Government of Maharashtra and N.C.T.E. Bhopal, to your Mandal as per the letter referred to above, I am pleased to inform you that your Mandal has been granted the permission for first time affiliation to start Bachelor of Education(B.Ed.) degree course on the name of Bhagwan Keni Shikshan Prasarak Mandal's Devta College of Education & Research at Kharegaon, Kalwa, Thane-400 605 on permanently No Grant Basis' with intake of 100 students for the academic year 2009-10.

The college has to fulfill the conditions mentioned in the letter under reference, issued by the Regional Director, National Council for Teacher Education, Bhopal.

The college has also to fulfill the following affiliation conditions -

- (1) that the conditions laid down by the University from time to time.
- (2) that the minimum attendance of all the students must not be less than 75% during the academic year and college will have to complete syllabus of all the subjects during the academic year.
- (3) Admissions should not be linked with donations.
- (4) that they will strictly follow the Ordinance 2802 in respect of preventing the colleges and Management of Colleges from accepting donation or capitation fees for admission of students in the Colleges, quoted in the University Circular No.Aff./Recog./49 of 1987, dated 4th February, 1987 (copy enclosed.)
- (5) that they should follow the norms as prescribed and circulated by the University vide No.CONCOLITS of 1988, dated 3rd March, 1988 and No.CONCOLIZTO of 1989, dated 21st July, 1989 (copies enclosed). Further they are requested to recruit the staff as mentioned in the letter issued by the National Council for Teacher Education, Chopal, before commencement of the course.
- (6) the college shall not admit the students over and above sanctioned intake.
- (7) the college shall appoint the teaching as well as non-teaching faculty as per the University and U.G.C. norms and also provide infrastructure facilities for the purpose.

Further, I enclose herewith copies of the Circulars No.Aff./Recog.l/188, dated 17th May, 2008 and No.Aff./Recog.l/189, dated 17th May, 2008 for your information and further necessary action.

In case you could not start the College from the academic year 2009-10, the permission granted to your Mandal will stand cancelled, which may please be noted.

You are requested to admit the students to the B. Ed. degree course through the Director, Higher Education, Pune for the academic year 2009-10.

Please inform the date on which the college started.
